

The Supplemental Nutrition Assistance Program (SNAP) is the nation's most important anti-hunger program.

## Who Does SNAP Reach?

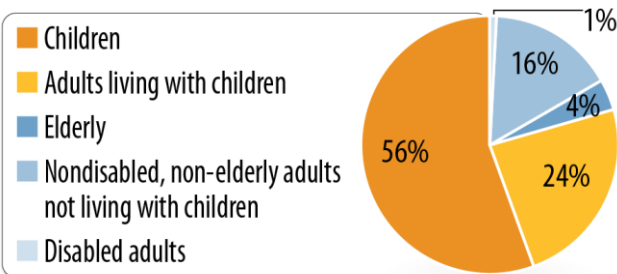
In Fiscal Year 2014, it reached:

- **4,350,000** California residents, or **11%** of the state population (**1 in 9 people**)
- **46,536,000** participants in the United States, or **15%** of the total population (**1 in 7 people**)

### In California many households still struggle to put food on the table:

- **15.0%** of households were "food insecure," or struggled to afford a nutritionally adequate diet, in 2011-2013.
- **7.0%** of the population was unemployed in December 2014.
- In 2013, average income in California was **10.6% below** the 2007 level.
- **16.8%** of the population lived below the poverty line in 2013.
- **23.1%** of children lived below the poverty line in 2013.
- **10.4%** of elderly lived below the poverty line in 2013.

**SNAP reaches needy populations: 63%** of eligible individuals participated in SNAP in California in 2012. In California in FY 2013, **91%** of households receiving SNAP had income below the poverty line (about \$23,850 for a family of four in 2014), and **67%** of households were in deep poverty, with income below 50% of the poverty line.

SNAP kept **353,000** people out of poverty from 2009-2012, including **167,000** children.

## What Benefits Do SNAP Recipients Receive?

SNAP targets benefits according to need. Very poor households receive more SNAP benefits than households closer to the poverty line since they need more help affording an adequate diet.

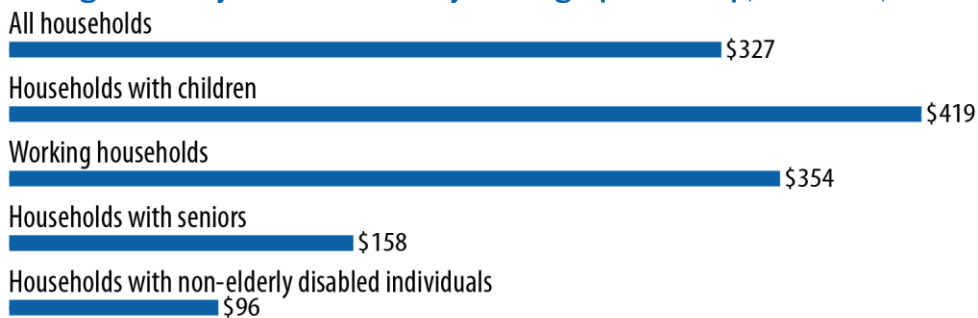
Households receive SNAP benefits on electronic benefit transfer (EBT) cards, which can be used only to purchase food at one of the 252,900 authorized retail locations around the country, including 25,900 in California.

\*This amount includes the temporary boost in benefits provided by the economic recovery legislation, which expired in November 2013.

Note: These amounts also include the temporary boost from the Recovery Act. In FY 2014, benefits will be lower by an average of \$8-10 per person.

## How Does SNAP Benefit the Economy?

Moody's Analytics estimates that in a weak economy, \$1 in SNAP benefits generates \$1.70 in economic activity.

SNAP benefits pumped about \$7.4 billion into California's economy in 2014.

**Note:** In California, low-income elderly and persons with disability receiving Supplemental Security Income (SSI) receive State Supplementary Payments (SSP) in lieu of SNAP benefits; these individuals are not eligible for SNAP.
