Senate Bill 1002 (De León) Aligning Opportunities for Health Act of 2014

PURPOSE:

Strengthen the alignment of Medi-Cal and CalFresh application and reporting periods to streamline benefit delivery and maximize access to federally-funded nutrition and health benefits for low-income families in California.

BACKGROUND:

Reduced hunger and improved access to nutritious foods are fundamental goals of CalFresh, the state's Supplemental Nutrition Assistance Program (SNAP) through which low-income Californians receive federally-funded food assistance. These objectives are strongly linked to supporting the overall health and well-being of children and adults who receive CalFresh. In an effort to further the connection between nutrition and health, and ensure that Californians receive federal benefits to which they are entitled, the link between CalFresh and Medi-Cal should be strengthened.

In 2013, Medi-Cal provided health coverage to more than eight million low-income Californians. Moreover, with the expansion of Medi-Cal eligibility under the Affordable Care Act, an estimated 1.4 million Californians are newly eligible for Medi-Cal as of January 2014. Many of these households covered through Medi-Cal also receive CalFresh.

Currently, CalFresh and Medi-Cal are integrated at the county level via the State Automated Welfare System (SAWS). This enables eligible individuals and families to enroll in both programs simultaneously. Recent efforts to promote horizontal integration between public benefit programs, such as CalFresh and Medi-Cal, have encouraged and supported dual enrollment at the initial point of application. However, this does not always happen. There are several reasons that a household may end up applying for one benefit but not the other or apply for benefits at different times. When they do, they are assigned multiple certification dates, resulting in the need to submit duplicative reports and paperwork. Consequently, families and counties are completing duplicate paperwork and resulting confusion may result in missed deadlines and list benefits.

This bill would build on efforts to improve both the health outcomes of low-income families and program efficiency by clarifying that a county may renew a person's Medi-Cal coverage if they are enrolled in CalFresh and requiring the Department of Social Services and the Department of Health Care Services to request federal waivers allowing for increased alignment for CalFresh and Medi-Cal application and redetermination processes.

PROPOSAL:

California has taken strides to improve dual enrollment and improve alignment between CalFresh and Medi-Cal. SB 1002 extends that work by improving program efficiencies for both administrators and the low-income families they serve.

This bill would require:

- Clarify that a county may renew a person's Medi-Cal coverage if they are enrolled in CalFresh. This will improve program efficiencies for both administrators and the low-income families they serve.
- Requiring that the Department of Social Services seek federal approval to use Medi-Cal enrollment to grant eligibility for CalFresh.
